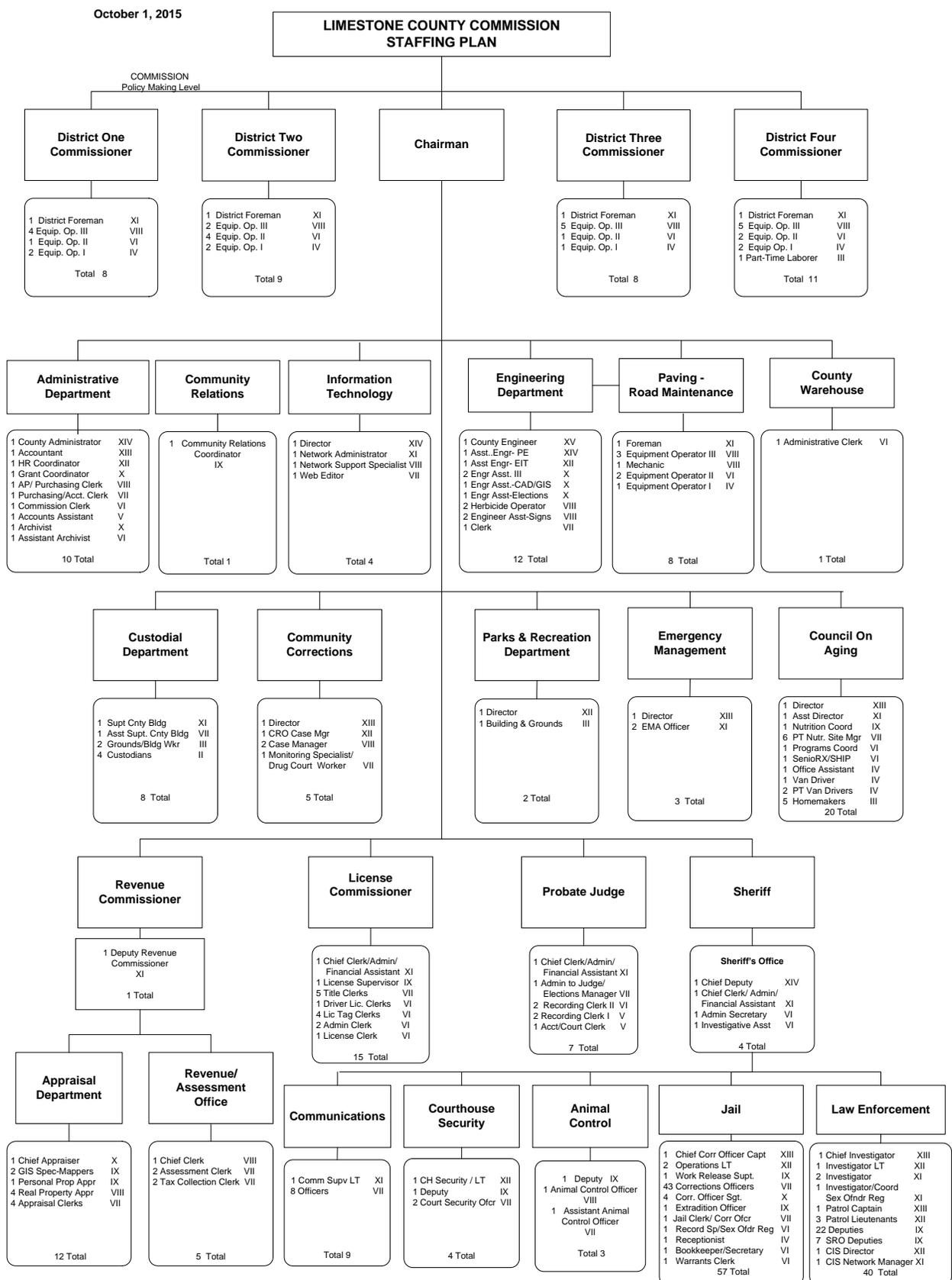

Commissioner Harrison stated that he values the county employees, but the proposed adjustment is too steep based on actual inflation figures. He said, for the past 15 years, the commission has approved a 3% COLA for its employees, and two of those years the employees received at 5% COLA. He added that state employees haven't received a cost of living adjustment since 2007 and the Social Security COLA for 2015 is 1.7%. He proposed cutting the COLA in half for the upcoming fiscal year and then taking a look at creating a formula for a cost of living adjustment.

Commissioner Black said, "I agree that we might need to cut back, but we've already talked to our department heads and put in the budget that we're going to give a 3% COLA." He added that the commission should look at Commissioner Harrison's suggestion to set a formula.

Commissioner Turner stated that a cost of living adjustment should not be automation, but should be compared to increases across the state.

Chairman Yarbrough stated that he agrees with both Commissioner Harrison and Commissioner Black. He added that the county should go ahead and do level funding this year and re-evaluate the method for determining the cost of living next year. He recommended the formula should also tie to county growth.

Chairman Yarbrough said the Limestone County Commission is in really good shape. He stated all the tough budget choices now would literally pay off in the future with the County's predicted economic expansion bringing in revenue. Chairman said he thinks in 8 to 10 years Limestone County will be the richest county in the State of Alabama.
