F.O.B.: **BID SHEET.** Date of Delivery: **AS REQUESTED.** Term: **NET 30 DAYS.**


You are invited to bid on the above specifications. Any substitutes offered must be submitted in detail. The right to reject any items or materials not of quality or under any provisions of this act is reserved.

Bids will be opened on **Tuesday**, the 12th day of **March 2019**, at **10:00 a.m.** and awarded on **Monday**, the 18th day of **March 2019**, at **10:00 a.m.**

REQUIREMENT: Pursuant to Alabama Code 31-13-9, as a condition of the award of any contract, the business entity or employer, and any of its subcontractors, shall provide a sworn affidavit and documentation that it will not knowingly employ, hire for employment, or continue to employ an unauthorized alien; that it is enrolled in the E-Verify program; and, during the contract period, it will participate in the E-Verify program and will verify every employee that is required to be verified under applicable state and federal laws.
