You are invited to bid on the attached specifications. Any substitutes offered must be submitted in detail. The right to reject any items or materials not of quality or under any provisions of this act is reserved.

Bids will be opened on Tuesday, the 12th day of March 2019, at 10:00 a.m. and awarded on Monday, the 18th day of March 2019, at 10:00 a.m.

REQUIREMENT: Pursuant to Alabama Code 31-13-9, as a condition of the award of any contract, the business entity or employer, and any of its subcontractors, shall provide a sworn affidavit and documentation that it will not knowingly employ, hire for employment, or continue to employ an unauthorized alien; that it is enrolled in the E-Verify program; and, during the contract period, it will participate in the E-Verify program and will verify every employee that is required to be verified under applicable state and federal laws. During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations.

LIQUID ASPHALT PICKED UP & DELIVERED TO JOBSITE

Liquid Asphalt is to meet the requirements of the Alabama Department of Transportation Standard Specifications for Highway Construction, 2018 Edition, Section 804 and Section 811 as applicable.

Truck deliveries shall be made full truckload units of 5000 gallons up to the maximum truck capacity as ordered. On shipments requesting less than 5000 gallons, it is agreed that the County will pay additional freight charges affecting the proposed delivered cost.

Charges at \$60.00/hour but not exceeding actual cost to the vendor will be allowed all truck units held beyond four (4) hours, which is the free period. The vendor shall supply the County with proper detention forms signed by a county employee for any claim regarding detention time.

Emulsified asphalt prices will be adjusted, monthly, based upon the Emulsified Asphalt Index as determined by the Alabama Department of Transportation. Method of determining the actual payment for asphalt purchases shall be as outlined in the *Alabama Department of Transportation Standard Specifications for Highway Construction*, **2018** Edition, Section 109-03e(1 & 2). The Base Index will be the Index published for March, 2019.

Alabama Department of Transportation form BMT-146, Bituminous Material Certificate of Compliance, shall be furnished when requested by the County Commission.

Asphalt shall be supplied to job site at a minimum temperature of 150F. Asphalt delivered at a temperature below 150F may be returned without charge at the discretion of the County Engineer or his representative.
