**TAX:** All applicable tax must be included in the bid price.


You are invited to bid on the attached specifications. Any substitutes offered must be submitted in detail. The right to reject any items, materials or services not of quality or under any provisions of this act is reserved.

**The period of this contract will begin on July 1, 2017 and will end on September 30, 2018.**

Bids will be opened on **Thursday, 15<sup>th</sup> day of June 2017, at 10:00 am** and awarded on **Monday, the 19<sup>th</sup> day of June 2017, at 10:00 a.m.**

**REQUIREMENT:** Pursuant to Alabama Code 31-13-9, as a condition of the award of any contract, the business entity or employer, and any of its subcontractors, shall provide a sworn affidavit and documentation that it will not knowingly employ, hire for employment, or continue to employ an unauthorized alien; that it is enrolled in the E-Verify program; and, during the contract period, it will participate in the E-Verify program and will verify every employee that is required to be verified under applicable state and federal laws. During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations.

Load will be scheduled and vendor will provide driver, truck and trailer to pick up and recycle tires. Limestone County Commission will provide a loader and operator to load tires into trailer. Tires must be recycled.

Price includes total cost per load, including transportation for each pick-up location.

Bid is for 25 or more loads.

No guarantee of number of loads.

Must be licensed and insured. Proof of license and insurance must be submitted prior to award.

Payment documentation must include weight tickets from a state certified scale.

Documentation must be provided guaranteeing that the tires were recycled.
