SPECIAL COMMISSION MEETING**

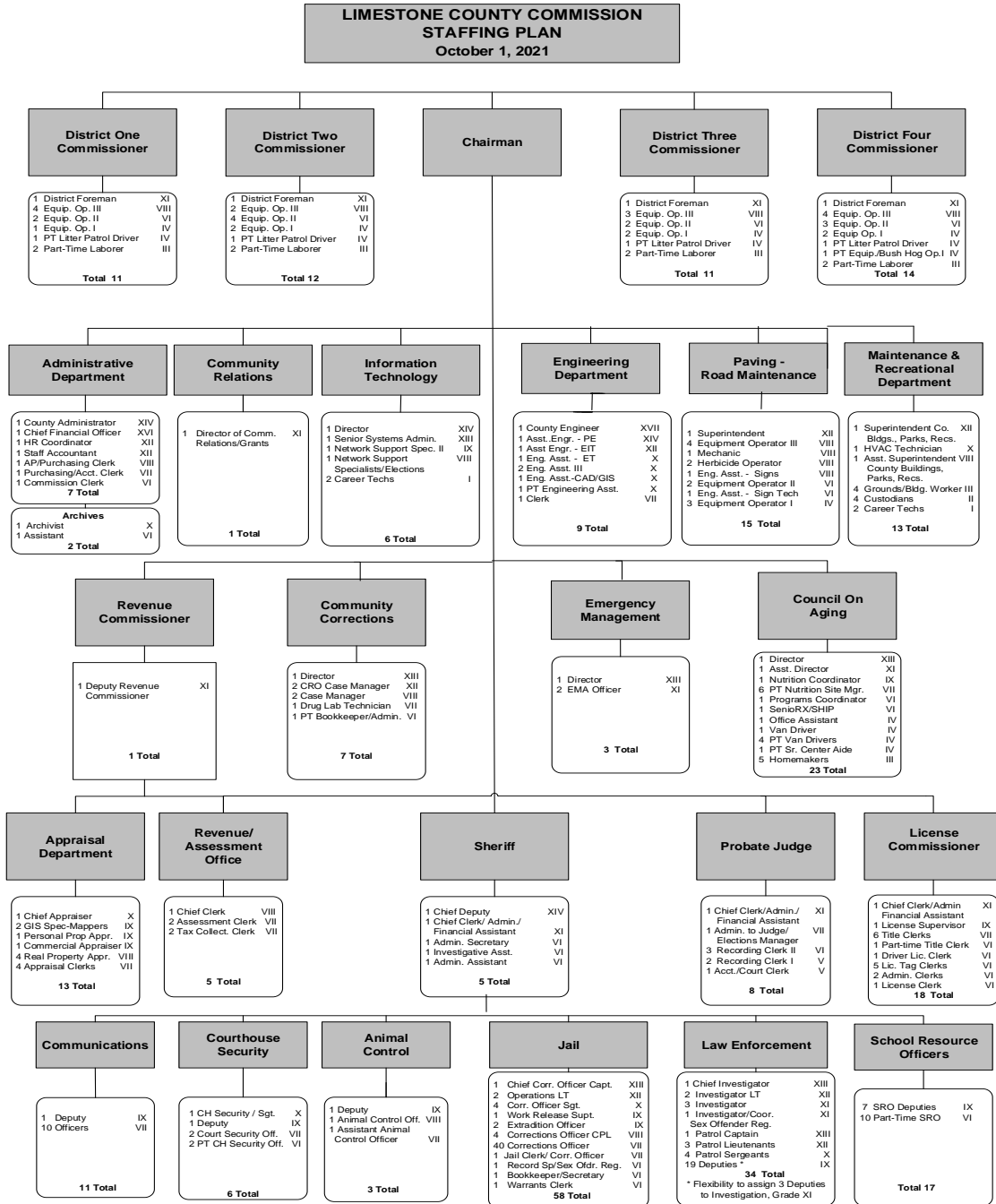
