WHEREAS, the Limestone County Commission entered a lease agreement on June 16, 2006 for rental of office spaces for the Limestone County Community Corrections Program; and

WHEREAS, the rental agreement has been month to month since July 1, 2011; and

WHEREAS, the County Commission is relocating Community Corrections to a county owned building; and

WHEREAS, the Limestone County Commission desires to terminate its month to month lease agreement with JKLL, LLC; and

Upon Motion having been made by Commissioner Jason Black and seconded by Commissioner Stanley Hill to terminate the month to month lease agreement with JKLL, LLC, effective October 1, 2018, with discussion thereon and a vote having been taken, upon which said motion carried by a vote of 4 to 0; and

THEREFORE, BE IT HEREBY RESOLVED by the Limestone County Commission to terminate the month to month lease agreement with JKLL, LLC, effective October 1, 2018.

**Relocation of Council on Aging**

WHEREAS, the Limestone County Council on Aging administrative offices have been located in the Athens Senior Center building at 912 Pryor Street; and

WHEREAS, the Limestone County Commission pays the salary of the Athens center manager and utilities at the Pryor Street location; and

WHEREAS, the Limestone County Commission is relocating the administrative offices of the Council on Aging to a county owned building; and

WHEREAS, the Limestone County Commission will continue paying the salary of the Athens center manager and consumable supplies for the center; and

WHEREAS, the Limestone County Commission will no longer use the facility for the Council on Aging administrative offices the County will no longer be responsible for utilities at the 912 W. Pryor Street building; and

Upon Motion having been made by Commissioner Ben Harrison and seconded by Commissioner Jason Black to relocate the Council on Aging to a county owned building, with discussion thereon and a vote having been taken, upon which said motion carried by a vote of 4 to 0; and

THEREFORE, BE IT HEREBY RESEOLVED by the Limestone County Commission to relocate its Council on Aging administrative offices to a county owned building and cease payment for utilities at the 912 W. Pryor Street building, effective October 1, 2018.

The Chairman asked if there was any discussion. There was no discussion. The Commission Clerk called the roll. Ben Harrison, aye; Jason Black, aye; Stanley Hill, aye; and Steve Turner, aye. Motion carries unanimously.

Items were discussed for the September 4, 2018 agenda.

County Engineer Marc Massey reported that the county bridge inspectors are working on bridge preservation as well as working to address problems and preserve the life of the county's bridges.

Commissioner Hill said his district is busy patching, bushwhacking and bush hogging. His district is also in the process of building a bridge of Redus Hollow Road.

Commissioner Turner said his district is also bush hogging and bushwhacking. He said they are having problems in subdivisions where grass and debris is being blown into stormwater drains and clogging the system.

Commissioner Black said his district is also in the process of cutting grass on the roadways. He said he received numerous calls about Nuclear Plant Road needing to be cut. However, portions of Nuclear Plant Road are not the responsibility of the County because it is maintained by Athens City.

Commissioner Harrison said his district is getting ready for bridge inspections. They have been busy cleaning the bridge area around Sportsman's Park and on Easter Ferry Road. The district is also bush hogging and patching as well as preparing to work on Barker Road.
