The awarded bidder must furnish written proof of product cost increase to the manufacturer's posted price list. The winning bidder will be allowed to adjust the product pricing only in the amount of the manufacturer's increase.

This Bid is effective from December 7, 2022 through December 6, 2023.

You are invited to bid on the attached specifications. Any substitutes offered must be submitted in detail. The right to reject any items or materials not of quality or under any provisions of this act is reserved.
