This Bid is effective from April 1, 2023 until September 30, 2023.

You are invited to bid on the above specifications. Any substitutes offered must be submitted in detail. The right to reject any items or materials not of quality or under any provisions of this act is reserved.

Bids will be opened on **Tuesday, the 14th day of March 2023, at 10:00 a.m.** and awarded on **Monday, the 20th day of March 2023, at 10:00 a.m.**

REQUIREMENT: Pursuant to Alabama Code 31-13-9, as a condition of the award of any contract, the business entity or employer, and any of its subcontractors, shall provide a sworn affidavit and documentation that it will not knowingly employ, hire for employment, or continue to employ an unauthorized alien; that it is enrolled in the E-Verify program; and, during the contract period, it will participate in the E-Verify program and will verify every employee that is required to be verified under applicable state and federal laws. During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations.

All bids must be sealed, and the word "BID," name of item, proposal number, and opening date must be marked on the outside of the envelope.

Miscellaneous Bid Notes

Projects that require a temporary traffic stripe will be coordinated by the County to coincide with paving operations prior to beginning work.

Unless otherwise agreed upon, the bidder shall begin work no later than 20 days after the work order has been submitted.

Contractor will be responsible for traffic control and protection of the placed material from traffic until the material has cured or hardened. Any claims of paint splatter to passing vehicles will be the responsibility of the contractor.

All materials and application methods shall conform to the *Alabama Department of Transportation Standard Specifications for Highway Construction, 2018 Edition*, which is in force at the time that the work is performed. ALDOT approved test reports shall be submitted to the County Engineer at the completion of each project if requested.

Quantities are estimates for determining low bidder only. Actual quantities to be placed will vary significantly from quantities shown. Bid will be awarded to one contractor based on the lowest total bid for all items based on the estimated quantities.
